

**The “Tedeschi Trucks Band Everybody’s Talkin” Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE AND LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia. Entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.

1. Eligibility. Participation open only to legal residents of the 50 United States and the District of Columbia, who are eighteen (18) years of age or older as of the date of entry. Void outside of the 50 United States and the District of Columbia, and where prohibited, taxed or restricted by law. Employees, officers & directors of Sony Music Entertainment (“Sponsor”), and its parent company, subsidiaries, affiliates, partners, dealers, advertising and promotion agencies, manufacturers or distributors of Sweepstakes materials and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees/officers/directors are not eligible to enter.

2. How to Enter. The Sweepstakes will begin on April 12, 2012 at 4:00 p.m. EDT and will end on May 22, 2012 at 12:00 p.m. EDT. Only one entry per person. If multiple entries are received by the same entrant, only the first entry submitted by that entrant will qualify for entry into the Sweepstakes; subsequent entries submitted by that entrant shall be disqualified. No automated entry devices and/or programs permitted. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

3. Prize.

One (1) grand prize winner will receive:

- Two (2) tickets to any headline Tedeschi Trucks Band performance in the US during 2012 after June 15th (**Transportation to and from the concert is not included in the prize**);
- Two (2) meet and greet passes for winner and guest to meet the band on the concert date; and

- Autographed heritage red Gibson® SG Special guitar.

Five (5) runner-up winners will each receive:

- An autographed copy of the Tedeschi Trucks Band's album, *Everybody's Talkin'*.

Winners and grand prize winner's guest must be at least eighteen (18) years old as of April 12, 2012. If any winner or the grand prize winner's guest is under the age of majority in the state in which he or she resides, such individual must obtain the written permission of his or her parent or legal guardian. Prizes are non-transferable. No substitutions or cash redemptions. Prizes may not be sold, bartered or transferred. Prizes do not include any additional expenses, including, but not limited to incidentals, meals, telephone charges, travel insurance, souvenirs, upgraded, air or ground transportation, federal, state and local sales or other taxes and surcharges which are the responsibility of each winner.

Approximate combined retail value of all prizes is Two Thousand Four Hundred Dollars (\$2,400.00). The approximate retail value of the prizes represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prizes turns out to be less than the stated approximate retail value, the difference will not be awarded in cash.

The winners and grand prize winner's guest will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within four (4) calendar days of prize notification. Grand prize winner will also be required to select prize concert date and advise Sponsor at least four (4) weeks prior to such tour date. If the winner rejects his/her prize or in the event of noncompliance with these Sweepstakes rules and requirements, such prize will be forfeited and an alternate winner may be selected from all remaining eligible entries. Upon prize forfeiture, no compensation will be given.

4. Random Drawing/Odds. Winners will be selected in a random drawing from all eligible entries received after 12:01 p.m. EDT on May 23, 2012. The odds of winning depend on the number of eligible entries received. Winners will be notified by telephone or email and if a winner cannot be contacted within two (2) days of first notification attempt, the prize will be forfeited and an alternative winner may be selected from all remaining eligible entries. By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these rules and the decisions of the judges, which will be final and binding in all matters relating to the Sweepstakes.

5. Conditions. All federal, state and local taxes are the sole responsibility of the winners. Any potential Winner may be requested to provide Sponsor with proof that such Winner is the authorized account holder of the email address associated with the winning entry.
